## PUBLIC LAW #111-36

Amended 15 January 2017

### TO ESTABLISH LAWS FOR ESCAPE AND RESCUE

Pursuant to the United States of America Republic Constitution Amendment 19, Section 2, Clause 2, wherein it states; *“The United States of America Republic shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof”*, there shall hereby be designated “Escape and Rescue” provisions to serve this purpose. This amendment shall go into immediate force.

Introduced as **Senate Joint Resolution 36**, with **38** co-sponsors and as **House Joint Resolution 36** with **38** co-sponsors, a request was delivered before the Continental Congress to honor and therefore establish laws for Escape and Rescue.

The resolution suffered no amendments, no exclusions, on demand that it became law.

**The 1<sup>st</sup> Continental Congress of the United States of America Republic publicly declared 2015 the national "Year of the United States of America Republic".** The document known as Public Law **111-36** was signed and passed into law on **15 January 2017** by the following **SIGNATORIES to this Legislative Act in Attendance;**

**Public law 111-36 on 15 January 2017**

**JOINT RESOLUTION**

**Authorizing and requesting the President to enact laws:**

**to proclaim and** establish laws for “Escape and Rescue” pursuant to the **Constitution and Laws of the United States of America Republic.**

**WHEREAS**, the United States of America Republic, being a perpetual corporation is an autonomous State government lawfully incorporated and chartered for the benefit and protection of “We The Moorish American People”, by its Declaration, National Constitution and By-Laws, and aforementioned Articles;

**WHEREAS** the United States of America Republic’s official language is the English language;

**WHEREAS** the Moorish American People have made a unique contribution in shaping the United States of America Republic as a distinctive and blessed nation of people and citizens;

**WHEREAS** the Moorish American People are a People of deeply-held religious convictions springing from the Holy Scriptures of the Holy Koran of the Moorish Science Temple of America and the Learning, Teachings and Truth of the Holy Prophet Noble Drew Ali. The Holy Prophet Noble Drew Ali led his People back to the Principles and standards of their ancient forefathers’ and –mothers’ Free National Principles and Standards;

**WHEREAS** the Principles of Love, Truth, Peace, Freedom and Justice inspired concepts of civil government that are contained in our Declaration of Independence and Constitution of the United States of America Republic;



**WHEREAS the Moorish American People**, are now in great comprehension that, as a Nation of People being Nationwide in scope to achieve peace as well as unity as a single harmonious Nation, there must be uniform Laws for the Nation. The **Constitution and Laws of the United States of America Republic** are *"the Rock on which our Republic rests"*;

**WHEREAS** the history of our Nation clearly illustrates the value of a Nation to be able to create and pass its own Laws that are beneficial to a Society to Enforce the Laws of the Nation. This is not to remove or change **The Moorish American People** from voluntarily applying and extending the learning, teachings and truth of the Holy Koran of the Moorish Science Temple of America in the lives of individuals, families, or in their society as a nation of People;

**WHEREAS** this Nation now faces great challenges that will test this Nation as it has never been tested before; and

**WHEREAS** that renewing our knowledge of Law, Divine and National and having faith in Our Universal Creator through Holy Scriptures of the Holy Koran of the Moorish Science Temple of America, the Holy Bible and the Great Qu'ran of Mohammed as we honor all the divine Prophets Jesus, Mohammed, Buddha and Confucius. Therefore, the **Constitution and Laws of the United States of America Republic** and knowledge of the aforementioned Holy Scriptures can only strengthen our nation. I, President Christopher H- Cannon: Bey, therefore establish with the consent of the Continental Congress the provisions as the **Laws of the United States of America Republic**:

**NOW, THEREFORE, be it Resolved** by the Continental Congress of the United States of America Republic in Continental Congress assembled, That the President is authorized and requested to designate the administration of said laws.

# TITLE 1 – CRIMINAL CODE

## CHAPTER 25

### ESCAPE AND RESCUE

#### **SECTION 751. Prisoners in custody of institution or officer**

Whoever escapes or attempts to escape from the custody of the Attorney General or his authorized representative, or from any institution or facility in which he is confined by direction of the Attorney General, or from any custody under or by virtue of any process issued under the laws of the United States of America Republic by any court, judge, or magistrate judge, or from the custody of an officer or employee of the United States of America Republic pursuant to lawful arrest, shall, if the custody or confinement is by virtue of an arrest on a charge of felony, or conviction of any offense, be fined under this title or imprisoned not more than five years, or both; or if the custody or confinement is for extradition, or for exclusion or expulsion proceedings under the immigration laws, or by virtue of an arrest or charge of or for a misdemeanor, and prior to conviction, be fined under this title or imprisoned not more than one year, or both.

Whoever escapes or attempts to escape from the custody of the Attorney General or his authorized representative, or from any institution or facility in which he is confined by direction of the Attorney General, or from any custody under or by virtue of any process issued under the laws of the United States of America Republic by any court, judge, or magistrate judge, or from the custody of an officer or employee of the United States of America Republic pursuant to lawful arrest, shall, if the custody or confinement is by virtue of a lawful arrest for a violation of any law of the United States of America Republic not punishable by death or life imprisonment and committed before such person's eighteenth birthday, and as to whom the Attorney General has not specifically directed the institution of criminal proceedings, or by virtue of a commitment as a juvenile delinquent under section 5034 of this title, be fined under this title or imprisoned not more than one year, or both. Nothing herein contained shall be construed to affect the discretionary authority vested in the Attorney General pursuant to section 5032 of this title.

#### **SECTION 752. Instigating or assisting escape**

Whoever rescues or attempts to rescue or instigates, aids or assists the escape, or attempt to escape, of any person arrested upon a warrant or other process issued under any law of the United States of America Republic, or committed to the custody of the Attorney General or to any institution or facility by his direction, shall, if the custody or confinement is by virtue of an arrest on a charge of felony, or conviction of any offense, be fined under this title or imprisoned not more than five years, or both; or, if the custody or confinement is for extradition, or for exclusion or expulsion proceedings under the immigration laws, or by virtue of an arrest or charge of or for a misdemeanor, and prior to conviction, be fined under this title or imprisoned not more than one year, or both.

Whoever rescues or attempts to rescue or instigates, aids, or assists the escape or attempted escape of any person in the custody of the Attorney General or his authorized representative, or of any person arrested upon a warrant or other process issued under any law of the United States of America Republic or from any institution or facility in which he is confined by direction of the Attorney General, shall, if the custody or confinement is by virtue of a lawful arrest for a violation of any law of the United States of America Republic not punishable by death or life imprisonment and committed before such person's eighteenth birthday, and as to whom the Attorney General has not specifically directed the institution of criminal proceedings, or by virtue of a commitment as a juvenile delinquent under section 5034 of this title, be fined under



this title or imprisoned not more than one year, or both.

**SECTION 753. Rescue to prevent execution**

Whoever, by force, sets at liberty or rescues any person found guilty in any court of the United States of America Republic of any capital crime, while going to execution or during execution, shall be fined under this title or imprisoned not more than twenty-five years, or both.

**SECTION 755. Officer permitting escape**

Whoever, having in his custody any prisoner by virtue of process issued under the laws of the United States of America Republic by any court, judge, or magistrate judge, voluntarily suffers such prisoner to escape, shall be fined under this title or imprisoned not more than 5 years, or both; or if he negligently suffers such person to escape, he shall be fined under this title or imprisoned not more than one year, or both.

**SECTION 756. Internee of belligerent nation**

Whoever, within the jurisdiction of the United States of America Republic, aids or entices any person belonging to the armed forces of a belligerent nation or faction who is interned in the United States of America Republic in accordance with the law of nations, to escape or attempt to escape from the jurisdiction of the United States of America Republic or from the limits of internment prescribed, shall be fined under this title or imprisoned not more than five years, or both.

**SECTION 757. Prisoners of war or enemy aliens**

Whoever procures the escape of any prisoner of war held by the United States of America Republic or any of its allies, or the escape of any person apprehended or interned as an enemy alien by the United States of America Republic or any of its allies, or advises, connives at, aids, or assists in such escape, or aids, relieves, transports, harbors, conceals, shelters, protects, holds correspondence with, gives intelligence to, or otherwise assists any such prisoner of war or enemy alien, after his escape from custody, knowing him to be such prisoner of war or enemy alien, or attempts to commit or conspires to commit any of the above acts, shall be fined under this title or imprisoned not more than ten years, or both.

The provisions of this section shall be in addition to and not in substitution for any other provision of law.

**SECTION 758. High speed flight from immigration checkpoint**

Whoever flees or evades a checkpoint operated by the Immigration and Naturalization Service, or any other National law enforcement agency, in a motor vehicle and flees National, State, or local law enforcement agents in excess of the legal speed limit shall be fined under this title, imprisoned not more than 5 years or both.
